Rechecking and Re-assessment Rules

1. Students have to apply for Re checking of the paper within 15 days after getting mark sheet.
2. Fee for rechecking shall be Rs. 50/- per paper.
3. Fee for reassessment shall be Rs.250/- per paper.
4. The UG student shall be entitle for rechecking /Reassessment only up to three papers (Maximum 3 papers) while PG student shall be entitled for rechecking /Reassessment only up to two papers (Maximum 2 papers) .
5. In rechecking, only marks obtained by the student in each question and total marks shall be rechecked. No assessment will be done at the university end.
6. In case of reassessment, first of all, Marks obtained by the students in each question and total marks will be rechecked. If any correction is there, in such marks, the correction will be made and the applicant will be informed and asked if still he/she wants to get the paper re- assessed of not.
7. After making correction in original marks and total marks, if applicant does not want to get the paper reassessed, then answer book will not be reassessed and fees paid by the applicant will be returned. The corrected marks will be declared as final marks.
8. The application received after the due date shall not be considered or accepted. The application shall be made in prescribed format of the university along with the fees payable. The application without necessary details shall not be considered and the fees paid shall be forfeited by the university.
9. The original result shall be the final result of the student; until, the modified result after re-assessment/rechecking is declared by the university authority.(i.e. Examination dept.).
