#### :: GCAS Registration for IITE Admission::

Applicant who wish to apply for IITE UG/PG programmes must get registered and apply on GCAS
portal first. Visit GCAS website on <a href="http://gcasstudent.gujgov.edu.in/">http://gcasstudent.gujgov.edu.in/</a>. Applicant who has
registered and made payment earlier on GCAS portal does not need to apply again on it.

#### :: IITE Admission Process after GCAS Registration::

- Applicant registered on GCAS portal has to register on IITE portal for i3T Entrance Test.
- The students shall have to appear in the i3T conducted by IITE after payment of i3T fees.
- To register for i3T and to remit the fees for i3T; log in to IITE website: www.iite.ac.in.
- Only candidates who have registered on GCAS portal will be able to register for i3T.
- Candidates have options available for selecting centre for appearing in i3T notified by IITE.
- IITE will conduct the i3T exam as per scheduled date, time and at the centre specified.
- IITE will prepare merit lists of the students on the basis on marks obtained in i3T.
- Based on the merit list, the student will have to appear in counselling at IITE on date and time scheduled for document verification and finalising admission.
- University will confirm and enrol the student turn by turn who will present in counselling.
- For further information students shall have to visit IITE website regularly. No excuse shall be entertained on the ground of lack of information.
- Do visit our website regularly for the latest updates on i3T as well as counselling.

#### :: IITE Admission Process after CUET-UG Result::

- Applicants who have appeared in CUET-UG or CUET-PG have to get registered first on GCAS portal; after registering on GCAS portal, he should get registered on IITE portal for IITE UG/PG Admissions, by providing GCAS registration and CUET-UG/PG registration details and paying prescribed application fees.
- Applicant who is registered on GCAS can remit the Registration Fees for admission to IITE.
- Applicants appeared in the CUET-UG/PG Test are exempted from appearing in IITE Entrance Test (i3T) conducted by IITE, provided that applicant has scored at least 50% of marks in the CUET-UG/PG Test. In case, the candidate wishes to improve the score of merit, he/she can opt for appearing in i3T. The higher the normalised score either in CUET-UG/PG or i3T shall be considered for calculating merit.
- For registration and remittance of the fees for i3T; log in to IITE website: www.iite.ac.in
- Applicants have the options of selecting the centre of i3T from the centres notified. IITE will conduct the i3T as per date, time scheduled, and centres notified.
- Based on the merit list, the prospective students shall have to appear in counselling at IITE on date and time scheduled for document verification and fee submission turn by turn who are present for counselling and confirming admission.
- Admissions will be finalised by IITE and will enrol the applicant as student.

#### **Programme Details:**

Indian Institute of Teacher Education is the University established by Government of Gujarat with a view to uplift the standards of Teacher Education. University has been offering programmes like B.Sc.-B.Ed., B.A.-B.Ed., B.Ed.-M.Ed., M.Sc./M.A.-M.Ed., M.Sc., M.A., M.Ed., and Ph.D. programmes. The University is inviting applications for various programmes through **GCAS Portal:** https://gcas.gujgov.edu.in/ from the eligible candidates who can carry out their studies at the Centre of Education, Indian Institute of Teacher Education Gandhinagar (Gujarat).

#### **Admission Process:**

#### **i3T** – Integrated Test for Teacher Trainee:

All the eligible candidates registered on GCAS, and candidates appeared in CUET-UG/PG Test and opted for i3T Test must appear in person for CBT (Computer based Test) i3T at the centre selected by the candidate. The i3T will be based on the topics mentioned below. IITE shall not provide any study material for the test. Mode of test is CBT (Computer based Test).

The MCQ test items will be in Gujarati & English.

Duration of the i3T for all programmes will be 90 minutes. Total time is 120 minutes.

#### Admission to UG and PG Programmes

- All eligible candidates shall have to appear in i3T- Integrated Test for Teacher Trainee conducted by the Indian Institute of Teacher Education (IITE) as per schedule mentioned in this brochure.
- To qualify in the i3T, the candidate will have to secure minimum 50% marks in the i3T.
- Admission to all UG and PG programmes will be offered on merit list prepared based on marks of i3T or CUET-UG/PG Test only.
- Applicant appeared in the CUET-UG/PG Test are exempted from appearing in IITE Entrance Test (i3T) conducted by IITE, if applicant has scored at least 50% of marks in the CUET-UG/PG Test. In case, the candidate wishes to improve the score of merit, he/she can opt for appearing in i3 (Entrance Test conducted by IITE). The higher the normalised score either in CUET-UG/PG or IITE Entrance Test shall be considered for calculating merit.

#### **i3T** – UG and PG Programmes

- To qualify in the i3T, the candidate shall have to secure minimum 50% of marks of total marks.
- Applicant appeared in the CUET-UG/PG Test must secure minimum 50% of marks in the CUET-UG/PG Test.

#### **Distribution of Seats**

- Category A: 90% of Seats Candidates who have registered on GCAS portal and have appeared in qualifying examination from the institutions located in State of Gujarat
- Category B: 10% of Seats Candidates who have appeared in CUET-UG/PG examination.
- If seats remain vacant in any of above categories, seats will be filled from candidates available in any category.

Note: The offshore candidates may be admitted to these courses subject to fulfilment of criteria fixed by Govt. of India time to time.

#### Allocation of Seats (Reservation Norms):

For admission, the seats shall be reserved for the Category A candidates and who are of Gujarat origin and falling under the following categories and in following proportion, namely.

•	Scheduled Castes (SC)	: 07 %
•	Scheduled Tribes (ST)	: 15 %
•	Socially and Educationally Backward Classes (SEBC)	: 27 %
•	Economically Weaker Section (EWS)	: 10 %

A candidate seeking admission on reserved seat shall be required to produce a
Certificate of Caste, provided that the candidate belonging to Socially and
Educationally Backward Classes and economically backward class shall be
required to produce a certificate to the effect of non-inclusion in Creamy Layer
in addition to the caste certificate.

- No caste certificate shall be valid unless it is duly stamped, signed, and issued by the competent authority of the Govt. of Gujarat.
- No certificate to the effect of non-inclusion in Creamy Layer shall be valid, unless
  it is duly stamped, signed and issued by competent authority of the Govt. of
  Gujarat.
- If a candidate fails to submit the certificates as required at the time of counselling, his/her candidature shall be considered for admission under unreserved (Open) category.
- The reservation of EWS is subject to guidelines of Govt of Gujarat and/or Govt of India and other Statutory Bodies time by time.

#### **Reservation for Physically Disabled Candidates**

5 % of the intake in each programme shall be reserved, in accordance with the provisions of the Rights of Persons with Disabilities (RPWD) Act, 2016 for the persons with disability who can perform the academic activities in the respective programme.

A candidate with disability shall have to submit certificate of disability issued and duly signed by the Civil Surgeon.

Explanation: "person with disability" means a person suffering from not less than forty per cent of any disability as certified by a competent medical authority.

#### **Counselling and Admission Procedure**

The candidates who are called for counselling and admission process are required to be present on notified date and time at the University campus situated in Gandhinagar with all required documents in original along with a set of photocopies with self-attestation for verification and submission of records. If there is any anomaly during the document verification observed and/or any information given is not as per the law of the land, the IITE reserves the right to deny admission or may cancel if information provided is not as per the regulations or law of land after confirming admission or as and when it is identified.

The admission is getting confirmed after remitting semester and registration fees for the respective programme on the date of counselling and admission.

The candidate's admission is valid if he qualifies in i3T test, and he gets admission after counselling process by the IITE only. Admission done in any other manner is invalid and is subject to cancellation.

#### Documents required at the time of Admission.

The candidate shall submit the self-attested copies of the following documents along with the printout of the registration form at the time of admission counselling:

- Qualifying Examination Mark sheet.
- School Leaving Certificate, Transfer Certificate or Migration Certificate
- Caste certificate for a candidate belonging to Scheduled Castes (SC), Scheduled Tribes (ST) and Socially and Educationally Backward Classes (SEBC), Economically Backward Class (EWS) issued by the competent authority of Govt. of Gujarat.
- Valid non-creamy layer (NCL) certificate of the family, issued by the competent authority of Govt. of Gujarat.
- Certificate of Physical Disability, issued and duly signed by the Civil Surgeon/ competent Medical Authority; in case of a Physically Handicapped candidate.

#### **Fees Structure:**

One time Enrolment/Registration fees of ₹ 1,000/- (Non-refundable) shall be payable at the time of admission for all programmes.

#### Fees for various programmes (per semester):

Fees for the 1<sup>st</sup> Semester is payable at the time of admission for confirming admission.

#### Guideline for User Registration and Admission Process on GCAS portal

#### A. New User ID Creation:

- Log on GCAS website,
- Look for an "Apply Now" option or register through the online registration below link http://gcasstudent.gujgov.edu.in/
- Online registration form filling with the required personal details
  - ⇒ **Name:** The student needs to fill in his/her name, exactly as it is mentioned in their HSE Marksheet/ 12<sup>th</sup> Standard Marksheet and/or Marks statement of eligibility.
  - ⇒ Date Of Birth: The student needs to submit the Date of Birth in DD/MM/YYYY format exactly as it is mentioned in their Higher Secondary Examination Marksheet (HSE)/ 10<sup>th</sup> Marksheet.
  - ⇒ Mobile No: In the format Country Code with the Ten Digit Mobile Number e.g. (91) 9632388997 (the student needs to share a valid mobile number which is easily accessible throughout the admission process)
  - ⇒ **eMail ID:** The candidate needs to provide a valid eMail ID, e.g. <u>abcdef@gmail.com</u> or <u>abcdef@yahoo.com</u> and others.

#### Review & final submission.

- An OTP will be sent on the registered Email ID and Contact Number.
- Creation of the UserID and Username and Password will be sent to the relevant Email ID and Contact Number.
- The candidate needs to immediately change the password post registration.

Note: A unique ID for candidate (UserID) will be created post-registration automatically. The candidate needs to use these credentials (i.e., UserID as Username and password) while logging in.

#### B. Admission Process:

- The candidate needs to login to the GCAS portal with the User ID and Password provided.
- An OTP will be sent on the registered Email ID and Contact Number.
- after Logging in, the candidate will be able to access the application form.
- The candidate will have to shortlist the programme/s offered by IITE.
- The candidate may choose respective programme/s offered by IITE as intended to apply for.
- After selection of the programme/s offered by the IITE, the candidate is to fill all the details required in application form.

- Review filled in application form. (It is recommended to review the entire application form before submitting finally)
- Remit Application fee through any of the approved Payment Gateway links.
- The soft copy of filled in application form will automatically be forwarded to the respective email ID of the candidate.
- **C.** Password Reset: The candidate may reset her/his password at any time following the steps as mentioned below:
  - Click on the Forgot Password tab available on the Login Page.

- Enter the Email ID, Application No. and Date of Birth of the User Candidate and click on Submit Button.
- An OTP will be sent on the registered Email ID or Contact Number.
- Reset the password.

#### D. Other Important Instruction:

#### :: IITE Process after GCAS registration::

#### Final submission by the student and entrance test (i3T) fee payment conducted by IITE:

- Submitted application on GCAS portal will be sent to the IITE.
- The students shall have to appear in the entrance test (i3T) conducted by IITE after registering and remitting fees for i3T.
- To pay the entrance examination fees; log in to IITE website: www.iite.ac.in.
- Only candidates registered on GCAS portal shall be able to pay the i3T fees.
- Candidate is to select any of the centres notified for i3T of one's choice.
- IITE will conduct the i3T exam as per scheduled date and time notified.
- IITE will prepare merit lists of the candidates on the basis of marks obtained in i3T.
- Based on the merit list, the candidate will have to appear in counselling at IITE on date and time scheduled for document verification and remittance of fees.
- IITE will confirm and enrol as the student.
- For further information candidates must visit IITE website regularly.

#### Dos and Don'ts'

- **Do download the Instructions and read it carefully.** Go through the entire Instructions before starting filling details on online application form.
- **Don't rush to fill the form.** Slow down and have patience. Rushing through your application can cause you to skip key sections and leave typos and misspellings.
- **Do enter your qualification mark.** Candidate has to fill in one's marks of qualifying examination, so before submitting your online application form finally, kindly ensure that the last date of submitting application is not ahead of declaration of result of qualifying examination.
- Don't confirm your online application form, without entering marks of qualifying exam. If the last date for filling online Application form is not ahead of declaration of result of qualifying exam, make sure your marks of qualifying examination is mandatory for finalising admission.
- Do fill your name and contact details correctly. You may fill in your name correctly as per your name in your School Leaving Certificate or Mark-Sheet of qualifying examination, it is advisable to enter the name as per the HSCE marksheet.
- Don't let others, e.g. Cyber Cafe personnel, to fill your application. They can make mistakes in typing your name and personal details, which can later create problems in your mark sheets.
- **Do upload proper Passport sized photograph.** You should upload proper passport sized photograph captured in a photo studio.
- **Don't upload casual photograph.** Uploading selfies or photos taken using Mobile/I-Pad/ Digi. Cam will not be accepted.
- Do upload properly scanned signature. Signature should be uploaded in signature column only.
- **Don't swap photograph and signature**. Signature and photograph should be uploaded in their appropriate columns only.
- **Don't register more than once with the same name.** You can use the same registered application to apply for any number of courses.
- **Do use Laptop or Desktop computer.** You may either use a laptop or desktop for filling up an application form.
- **Don't use Smartphone**. Using a Smartphone to fill your application form can lead you to miss out some important details to be filled up.
- **Do use preferably latest version of browsers.** The software used is created suitable to the latest widely used and user-friendly browser (Google Chrome, Mozilla Firefox).
- **Don't use older version of browsers.** The software may not enable you to fill some detail using an older version of browser.
- **Don't take advice from Cyber Cafe personnel.** You can use the facility of Cyber Cafe or any Computer Centre, but not their advice for filling up the form.
- **Do pay only prescribed registration fees.** Pay the online registration fees using personal Debit or Credit Card or Net Banking of self or relatives.
- **Don't pay anything extra other than prescribed registration fees.** Payment of extra fees for filling up application form is unwanted.
