- Resolution 7 The Council discussed the matter and decided to opt for New Guidelines for Assessment and Accreditation.
- Patel Krisha enrolled in B.Sc. B.Ed. programme in the academic year Agenda - 8 2022-23. She has passed the Sem-1 examination with 25 credits and 602 marks out of 850 marks as per the IITE syllabus 2022-23. She was not allowed to appear for semester - 2 examinations due to less attendance. The new syllabus is implemented from the year 2023-24, the total credit is 20 and the total marks are 550 in the 1st semester. Comparing both, the syllabus it appears that the candidate has completed a course with more credit than the current syllabus of Semester-1, in particular current Semester-1 has additional subjects such as Hindi Language, Performing Arts and Creative Expression, Indian Ethos and Evolution of Indian Education which are not related to the subjects of the next semesters and thus. It does not seem to have any impact on the Semester-2 syllabus. Keeping these things in mind, the candidate has been asked to give in writing that the decision taken by the members of the Academic Council will be acceptable to her. Conditional admission is to be granted to her. The matter is put before the Council to quide as to how and what syllabus to be followed in the said case. (Center of Education)
