Agenda from the desk of the Chairperson.

Agenda-1. A meeting of the Committee for Creation of Academic and Administrative Posts at IITE was arranged on 10.06.2024. Committee has recommended to create and fill various 45 academic posts and 62 administrative posts on contractual basis at IITE for the academic year 2024-25, based on the norms and staff requirement for various approved Teacher Education programmes at IITE as per NCTE norms and as per University Administration requirements. The same was placed before 67th Meeting of the Finance Committee and has been

approved and recommended vide resolution 13 by the Finance Committee. Similarly, agenda for creation of academic posts was placed before 31st meeting of the Academic Council and has been approved and recommended vide resolution 5 by the Academic Council. The Summary of these posts is annexed herewith. Agenda is put before the Council to discuss the matter and approve the recommendation of the Committees/Council.

Resolution-1 The matter was discussed and it was resolved that based on the recommendations of the Finance Committee and the Academic Council, various academic and administrative posts at IITE will be filled on a contractual basis for the academic year 2024-25 to meet the mandatory requirements of NCTE and University Administration. (Annexure – 1: Summary for Administrative Posts & Academic Posts for Academic Year 2024-25)

Agenda-2. IITE must obtain permission for the ITEP (Integrated Teacher Education Program) and, as per the NCTE (National Council for Teacher Education) conditions, it is mandatory to introduce multidisciplinary programs to gain recognition for the integrated program. After discussions with the Education Department and the Minister of Education and oral permission, it has been decided that, starting from the current academic year, IITE will reintroduce M.A. and M.Sc. programs to students who have completed their undergraduate degrees and B.Ed. in their respective subjects. Moreover, in accordance with the directions and recommendations of the UGC (University Grants Commission), the curriculum framework and credit framework for the PG (Postgraduate) programs will be adopted as per letter dated 14th June, 2024 aligning with NEP (National Education Policy) recommendations. As per resolution 9 of the 31st meeting of the Academic Council and resolution 1 of the 32nd meeting of the Academic Council, council has agreed and recommended to make necessary amendment in IITE Ordinances for the same. Council also decided and recommended to introduce Diploma in concerned subject as per the recommendation of the UGC.

Agenda-3. As per Resolution No. 25 of the 35th Executive Council meeting, a Committee for Work Review was formed by the Vice-Chancellor.

The committee reviewed the matter in accordance with the Act, regulations, orders, notifications, and annual reports of IITE. 3 meeting of the said committee were arranged and committee has submitted report for the same.

Resolution-3 The council discussed the report presented by the committee and resolved that the University should reply to the government, stating the following facts:

- No permanent administrative positions are notified by Government of Gujarat after 201. It was notified as on 29.07.2011 vide notification no. TEU-2610-1775-Kh.
- So, no permanent administrative positions are notified after affiliating teacher education institutes (B.Ed. Colleges/DIET).

So, it was resolved that department concerned should be communicated in response of letter no. ED/0602/06/2023 dated 01.07.2023, that no permanent administrative positions are notified by the Education Department, Government of Gujarat after affiliation of DIETs and Teacher Training Institutes (B.Ed.) in year 2019-20 and 2020-21 respectively.
