The matter is presented before the Council for guidance and discussion.

Resolution-5. The Council discussed the matter and resolved to adopt the leave rules as per UGC Regulation - 2018, as approved and adopted by Government of Gujarat, incorporating it into the IITE Regulations, 2023. The same shall be amended in accordance with any directions issued by the UGC/ State Government from time to time, with approval of the Executive Council.

> Further Council empowered the Vice Chancellor, IITE to approve the notification of amendment in the said regulations and date of implementation of these amended regulations shall be 1st September, 2024.

This agenda is presented to discuss and decide the provision/criteria to be Agenda-6. consider for the award of Gold Medal and Rank Certificates during 7th Convocation.

> Following Regular batches students passed their last semester of study during May-2024 Examination for which Ranks needs to be decided and for the same decision needs to be made that from the provision of Regulation 2021, 29(13) and Regulation 2023, 28 (13) which regulation to be considered.

Resolution-6. The Council discussed the matter and resolved to adopt provisions of IITE Regulation-2021 for determining student ranks and awarding gold medals for the next convocation.

Agenda-7. As per notification ITE-1217-57-Kh2, dated 13/07/2017, the Education Department sanctioned the 7th pay benefit to non-teaching employees of IITE. According to this resolution, transport allowance for non-teaching employees was stopped. IITE has sent a proposal to the Commissioner of Higher Education to sanction transport allowance to regular non-teaching employees of IITE, and it is currently under process in the government.

As per notification PGR/102022/O-360/Pay Cell (CH), dated 24/09/2022, the Finance Department issued a notification for the revision of Transport Allowance, and a copy of the same has been sent to Universities.

As per letter no. 1977, dated 04/06/2024, TA has been sanctioned to all regular non-teaching employees from 01/04/2024, as per resolution no. 29 of the 35th meeting of the Executive Council.

As per the application received, regular non-teaching employees demanded the sanction of transport allowance as per the resolution dated 01/10/2022, sanctioned by the Government of Gujarat.

The matter is presented before the Council for discussion.

- Resolution-7. The Council discussed the matter and resolved to sanction the payment of transport allowance to all eligible non-teaching employees from 1st October, 2022. It was resolved that budgetary provisions be made to approve the transport allowance from the University Development Fund Account. Furthermore, it was resolved that an undertaking from the employee shall be taken to abide future action taken, if any, in this regard from the University.
- Agenda-8. As per the BWC meeting held on 24/06/2024, a resolution was passed and approved by the BWC. Considering the need for new classrooms for students, based on SVNIT reports and the requirements for the upcoming year at IITE, building an additional property on top of the Skill Center has been proposed to alleviate the current classroom shortage. The Committee has decided to complete the work with the help of the Capital Project Division (Govt. of Gujarat.

Based on the current construction rates, the estimated cost for the new building is between ₹18,000 to ₹20,000 per sq. meter. Approximately 500 to 550 sq. meters of construction will be done on the first floor of the Skill Center.

The agenda is placed before the Executive Council (EC) for approval of the amount required for the construction of the first floor of the Skill Center.

The matter is now placed before the Council for ratification and approval.

- Resolution-8. The Council discussed and approved the matter of additional classroom construction on the existing property and on top of the Skill Centre, as recommended by the Building and Works Committee (BWC). It was resolved that the estimated cost for the construction has been approved, and furthermore, the project shall be handed over to the Capital Project Division (Government of Gujarat). The funds will be transferred to the Capital Project Division (Government of Gujarat), Gandhinagar, for further project work to construct the classroom. The expenditure incurred shall be made from the University's development fund.
- Agenda-9. From 5-1-2024 to 31-01-2024 Mr. Virendra Patel was asked to facilitate the recordings of Ek Bharat Shrestha Bharat- Shiksharth Teacher Education programme & the regional Teams came for recording from the distant parts of India.

For the work done by Mr. Virendra Patel, on 5/02/2024 the note was put forward for the approval of payment. The opinion of the former Director, Centre of Extension services was taken as per the remarks received on 1/4/2024.

The opinion of the former director, CoExt was put forward again on file on 19-04-2024 for guidance/approval of payment.

The matter is put forward to the council to decide/approve payment of Mr. Virendra Patel from 5-1-2024 to 31-01-2024 i.e. for 17 days as per pro rata of the salary of Assistant professor on contractual basis as well as from which budget head of EBSB, it should be paid.

- Resolution-9. The Council discussed the matter and resolved that the payment to Mr. Virendra Patel shall be made on a pro-rata basis for the number of days he actually worked. For counting this amount, equivalent monthly salary paid to an Assistant Professor working on a contractual basis at IITE shall be considered. Furthermore, it was resolved that before proceeding with the payment, Centre shall verify that no payment has been made to him for any other assignment or work during this period at IITE.
- Agenda-10. Shefali S. Patel, Adhyapak Sahayak, V. R. Bhakta College, Kamrej, Surat, has filed a SCA in the High Court of Gujarat (Application No. R/SCA/10416/2024), contesting the denial of her Teacher Recognition. In her appeal, she has named the Indian Institute of Teacher Education (IITE) as one of the respondents.

The High Court of Gujarat has issued a notice to IITE, instructing the Institute to appear in court. The hearing is scheduled for 27th August 2024.

This matter is submitted for the information and consideration of the Executive Council.

- Resolution-10. The Council took note of the SCA filed by Shefali S. Patel regarding her teacher recognition. Furthermore, the Council ratified the appointment of Advocate Mr. Shyam Shah for legal litigation on behalf of the University. The Council resolved that the Vice-Chancellor is empowered to decide and approve the advocate's fees as per IITE Regulation 2(24)(d)(10).
- Agenda-11. As per resolution 31 of the 35th Meeting of the Executive Council, a Committee was constituted vide office order no. 2004, dated 11.06.2024 to submit a report about reviewing the process of the Inquiry Committee constituted vide office order no. 2656 dated 06.04.2022 and other pending matters of the Dr. Nishant Joshi, Assistant Professor, IITE. As per the said resolution, The Vice-Chancellor was empowered to make decisions and necessary actions based on the report submitted by the Committee.

The Committee has submitted its report on 26.07.2024. As per recommendation of the Committee and file order received, an office order no. 2388 dated 12.08.2024 has been issued to cancel the process done by the Inquiry Committee and to file the report of the Inquiry Committee.

The matter is presented before the Council for ratification.

Resolution-11. The Council ratified the decision taken and notification based on the report of the committee.

As mentioned in the report students have not passed the examination in define time limit and it is also mentioned that necessary approvals of the competent authority needs to be taken by the Department to allow the students to appear in the Examination after one year in Semester-4. Committee reported that based on inspection of the related documents it seems that approval of the competent authority is not taken by the department before allowing these students to appear in course work examination.
